Thank you for your emails of 23 and 29 February 2024 to Wellington City Council (the Council) requesting the following information about the Wadestown Community Centre:

- We are keen to view any documents related to the sale / gifting of the Wadestown Community Centre to WCC in the early 1900's onwards. We obtained a certificate of title dated 1909 from WCC archives but archives didn't seem to hold any earlier correspondence regarding the offer of the building or land by the gentlemen's club to WCC prior to the land transfer occurring back then.
- We are seeking any recent emails or documents regarding WCC officer advice to Councillors that may have informed their 2021 and 2024 decisions to sell the Community Centre. We are also seeking any emails or documents from the WCC legal team to WCC officers or councillors regarding the intention for sale of the Community Centre.
- Please provide a list of all records and items related to the Wadestown Community Centre that are currently held by the WCC Archives, including listing items that are not yet digitised.
- Please provide a list of all business records, notes, emails and other items related to the Wadestown Community Centre that are currently held by the WCC Communications and engagement team including email correspondence over the last 5 years about this topic with NZ Herald and Stuff news reporters (who may include Tom Hunt, Erin Gourley and Georgina Campbell amongst other public media staff).
- Please provide a historical timeline about the main historical or significant events involving the Wadestown Community Centre and WCC between years 1900-2024. Please also describe the origins and sources of this historical information.
- Please provide a historical timeline of the main events, discussions and WCC actions related to the land / building transfer of the Wadestown Community Centre to WCC between the years 1900 and 1950.

Your request has been considered under the Local Government Official Information and Meetings Act 1987 (LGOIMA).

For context, the sale decision for the Wadestown Community Centre was carried over from the previous Long Term Plan (LTP). The decision that it should remain in the LTP was due to the findings of the <a href="Te Awe Māpara - Community Facilities Plan">Te Awe Māpara - Community Facilities Plan</a>, which was approved by Council in 2023. The limitations of the building and the Council's decision to divest of it are discussed on page 87 of this plan.

Each of your points for requested information is addressed below.



# Documents related to the sale / gifting of the Wadestown Community Centre to Wellington City Council

The building that houses the Wadestown Community Centre was built in 1909 by the Wadestown Club Incorporated. Wadestown Club Incorporated went into liquidation, and the building was purchased by the Wellington City Council in the early 1930s. The building was opened as the Wadestown Branch library in 1932 and, following construction of the current library building, was converted to the Wadestown Community Centre.

We refer you to a copy of correspondence from the liquidator, dated 30 July 1930, attached as Appendix 1.

# Emails and documents that may have informed councillors' 2021 and 2024 decisions to sell the community centre

This information is attached as Appendix 2. While we generally limited our documents to those dated after 1 January 2021, some communications from prior to this date are included.

In the development of the 2024 LTP budget, we have had to focus on addressing some key challenges including infrastructure challenges, affordability constraints and overall balance sheet resilience.

To tackle those challenges and make sure we have a sensible budget, some trade-offs are required, and a range of proposals were put to elected members by Council staff. A summary of the different approaches that are being used to help manage the budget and key proposals are outlined below. Closure of Wadestown Community Centre is one of a number of proposals to achieve a sustainable budget for the period 2024-34.

The following proposals are a summary of those included in the 2024 LTP, which is currently out for consultation:

## Capital works

- Rephased and re-prioritised the capital programme so we invest where it is needed.
- Some projects have been stopped completely, others delayed, or others might be delivered differently
- We are doing the full cycle network we planned but using different materials so it's cheaper overall.

## Levels of service

 Some level of service changes – big and small (annual fireworks are cancelled, closing Arapaki earlier, shutting Khandallah Pool and the Wadestown Community Centre).

# Increases to fees and charges

• Fees and charges have changed across a range of services – details are on the Council's website.

## Other

 Financial decisions, such as not fully funding depreciation for some of our assets in the short term

We've done some research into the history of the Wadestown Community Centre, and can confirm that Council has owned the building for the best part of a century (as per the current property owner details on the rates records).

What is now the Wadestown Community Centre was built in 1909 by what was known as the Wadestown Club. The building was purchased by the WCC in the early 1930s after the Wadestown Club went into liquidation and it opened as the original Wadestown Branch Library in 1932.

Following the construction of the current Wadestown library building, the former library was then converted to the community centre that it is today.

I'm not aware of the background to the hall or what conditions where attached but I will ask officers if there is any information and come back to you.

The key reasons for proposing selling the hall today is because of its lack of accessibility to all parts of the community (with various levels of mobility), the costs associated with upgrading it making it fit for the future (outweigh the value of the site and building) and the availability of other halls in the area to provide space for larger gatherings.

### **Dear Councillors**

As promised at our meeting last week (with myself and Laurinda) I undertook to come back to you with more information about the Wadestown Community Centre.

As you know the Crèche has decided to cease operations and they are in the process of removing their assets from the building. The Toy Library is still operating from the site. You have suggested that the building be sold and that the proceeds fund an extension to the Wadestown Library for community meeting spaces.

By way of background Jenny Rains has advised that:

In 2012 Council considered selling the building on Pitt Street however this was put on hold with further work to be done in 2016/17 financial year:

"Wadestown Community Centre/Vogelmorn Hall – we had originally considered opportunities to deliver shared services from the Wadestown Library site and sell the community centre. We've decided to postpone this work in the short term and will review the future use of the community centre facility in 2017/18 after discussions have taken place with users."

However Jenny advises that this work was not done. It should be noted that the intent of the decision was to allow time to discuss options with the then users - this was primarily the Creche and the toy library. Casual bookings were minimal as the only usable space was (is) the small mezzanine balcony.

As the creche is moving out, it is timely to revisit the option of selling the building.

At the time there were discussions about extending the library , however there were a couple of factors that complicated this discussion. The Village Green group had very strong views on retaining the Philip Myers Park and the reserve designation of the space at the time would not support this. However the latter restriction has changed as both parcels of land were gazetted as Local Purpose (Community) Reserve in 2017. This was consistent with an action in the Suburban Reserves Management Plan 2015.

In terms of advancing the concept of a sale of the community centre and extending the Wadestown Library it's important to note that this proposal is not contained within the current LTP or Annual Plan. There has also been a commitment to developing a community facilities strategy and work is underway on the review of our Libraries strategy which would inform any discussion about Wadestown.

At our meeting I suggested that it should be first established whether additional community spaces are actually needed in Wadestown. Our team could work through the formal process of divesting the property as well as looking at needs and spaces after the election. With our current focus on the Central Library closure and replacement services, we don't currently have capacity to undertake this work.

As there are still requirements around generating revenue from our Community Centres, we will seek community short term uses for the space in the meantime, until we can get the work mentioned above completed.

1.Amend Rec 2 (page 23) to show a revised end consultation date of 14 August 2023 (this is still 2 weeks prior to the existing oral submissions date) We are happy to proceed with 7 August as the revised end of date – this provides over 5 weeks consultation period.

We are expecting a large response (which, from experience, is usually received within the first few weeks of consultation). There are only two of us who will be collating all of the responses, theming them and then responding appropriately. This take a significant amount of time, and I would be very cautious about reducing this analysis more than it currently is (two weeks). We have to get a final draft ready and share that with all internal stakeholders and check it with our advisory groups – this all takes a great deal of time and navigating people's already full loads.

We think an extension of one week balances the risk of not having a Plan ready by 12 October with making sure we have plenty of consultation time.

# 2 Amend the Community Facilities plan to include:

1. Wadestown community facilities to be included in a Western cluster of suburbs incorporating Wadestown, Highland Park, Wilton and Northland (this better reflects the grouping of the adjacent suburbs and access between suburbs via public transport).

#### And

2. Rename the "western" cluster to be known as "Onslow" and incorporating Crofton Downs, Ngaio, Khandallah, Broadmeadows and Kaiwharawhara

We have considered these two proposals together.

Through our extensive analysis we found that while the catchments for Wadestown Community Facilities don't necessarily extend into Khandallah and Ngaio. The facility catchments for Khandallah and Ngaio are overlapping into Wadestown.

Based on our catchment analysis, the "western" cluster of facilities are interrelated – whatever happens in Wadestown will affect how people use and access facilities in Khandallah and Ngaio, and, similarly, any changes we make to facilities in Khandallah and Ngaio will influence use of Wadestown facilities. Our recommendation is to bring Actions F20 and F9 together and call it "Western/Onslow cluster of community facilities".

- 3. The known likely placement of the planned Karori city end new playground
- We propose to add the following to considerations under Action U8 Ian Galloway Park
- "Investigation of a Karori city-end play area space is part of the scope of the planning work underway at lan Galloway Park."
  - 4. The lan Galloway park plan to be defined as a "master plan" to better reflect the breadth of activities and facilities required
  - 5. The timing and placement of the toilets identified for Ian Galloway Park reflect the decision made by Council for the 23/24 Annual Plan ie Agree to recommend funding of \$0.15m (from reprioritising the existing capital programme) for temporary toilets installed on southern end of Ian Galloway Park by the BMX tracks
  - 6. Happy to change Action U8 to "Complete a master site plan for the park with associated needs assessment for Ian Galloway Park in 2024/25 and develop a public toilet with funding confirmed in the 2023/24 Annual Plan (ie Agree to recommend funding of \$0.15m, from reprioritising the existing capital programme, for temporary toilets installed on southern end of Ian Galloway Park by the BMX tracks)."
  - 1. A stronger focus on partnering with schools in respect of their recreation and sporting facilities e.g. Onslow College

The Plan articulates partnering as one potential and important way to evolve facilities towards a more sustainable and cohesive network (refer to: point 3 of Section 4.1 – p. 22 of the Plan; 4.1.2 (p. 24) partnership facilities as a method of collaboration; and refer to section 3.2 for Council's various roles, partner – being one such role). Additionally Action I.7 is "explore partnerships with MoH and MoE"

We do not recommend the Plan at this stage narrow its focus on any particular schools until the investigative work is undertaken. However, we could add the following to Action F8:

- Under the Action column add to considerations include: "Exploring possible partnerships with schools and other facilities in the area."
- Add to the Facilities column "Non-Council facilities in the Johnsonville area, such as Onslow College"



Those of us who were involved with the original Community Forum submission on this subject back in the early 2000s which involved nearly two years work with Council officers and a Council architect, led by a Council appointed Facilitator, and other iterations since then, will be aware of the dangers of creating an expectation in our community about the possibility of an exciting new community facility only to see it ultimately fail because a thorough financial feasibility study was not conducted at the beginning of the process.

I believe it is vital that before any planning discussions are held or community involvement is sought that advice be sought from the Team leaders of Community Services as well as Libraries and Community facilities who are the relevant council business units involved on how such a project might best be progressed.







# **Dear Councillors**

As promised at our meeting last week (with myself and Laurinda) I undertook to come back to you with more information about the Wadestown Community Centre.

As you know the Crèche has decided to cease operations and they are in the process of removing their assets from the building. The Toy Library is still operating from the site. You have suggested that the building be sold and that the proceeds fund an extension to the Wadestown Library for community meeting spaces.

By way of background Jenny Rains has advised that:

In 2012 Council considered selling the building on Pitt Street however this was put on hold with further work to be done in 2016/17 financial year:

"Wadestown Community Centre/Vogelmorn Hall – we had originally considered opportunities to deliver shared services from the Wadestown Library site and sell the community centre. We've decided to postpone

this work in the short term and will review the future use of the community centre facility in 2017/18 after discussions have taken place with users."

However Jenny advises that this work was not done. It should be noted that the intent of the decision was to allow time to discuss options with the then users - this was primarily the Creche and the toy library. Casual bookings were minimal as the only usable space was (is) the small mezzanine balcony.

As the creche is moving out, it is timely to revisit the option of selling the building.

At the time there were discussions about extending the library , however there were a couple of factors that complicated this discussion. The Village Green group had very strong views on retaining the Philip Myers Park and the reserve designation of the space at the time would not support this. However the latter restriction has changed as both parcels of land were gazetted as Local Purpose (Community) Reserve in 2017. This was consistent with an action in the Suburban Reserves Management Plan 2015.

In terms of advancing the concept of a sale of the community centre and extending the Wadestown Library it's important to note that this proposal is not contained within the current LTP or Annual Plan. There has also been a commitment to developing a community facilities strategy and work is underway on the review of our Libraries strategy which would inform any discussion about Wadestown.

At our meeting I suggested that it should be first established whether additional community spaces are actually needed in Wadestown. Our team could work through the formal process of divesting the property as well as looking at needs and spaces after the election. With our current focus on the Central Library closure and replacement services, we don't currently have capacity to undertake this work.

As there are still requirements around generating revenue from our Community Centres, we will seek community short term uses for the space in the meantime, until we can get the work mentioned above completed.

Kia Ora Rebecca,

I'm taking from your comment that you are committed to this being a capital item. In that case, your suggested wording is appropriate. It's worth bearing in mind that any capital facility comes with OPEX implications, and securing that additional funding would be another matter. Using the reinvested into the *local community* wording lets us look at fuller range of options for consideration.

In terms of the 'Wadestown community' vs 'Local Community' wording, that change would be an option for you, but again, it does commit to whatever intervention being located in Wadestown where a suitable site for investment may be adjacent in Wilton or Crofton Downs, with the benefit accrued by Wadestown locals, among others. Officers would take the wording of 'Local Community' as being Wadestown and immediately adjacent suburbs.

Summarising the wording options, see below – the red brackets is our suggested approach, and the blue captures what I believe your current intent is.

# Wadestown Community Centre: Early History and Timeline

# **Early History**

The building which now houses the Wadestown Community Centre was originally 'The Wadestown Club,' a private club which was incorporated in mid-1909 under the drive of three locals; George Nash (a local dairy farmer), Charles Joplin (a local teacher at the Wadestown school) and Robert Moffat (clerk at the General Post Office in Featherston Street). At the time the suburb was growing quickly following the decision of the Onslow Borough Council to allow Wadestown to secede from the borough and to amalgamate with Wellington City in 1907. This occurred around the same time that former 'estates' in the area began to be subdivided with sections being advertised to Wellington's new emerging middle-class of professionals. Sales in the area were buoyed by the proposal to extend the tramway to Wadestown which would allow easy commuter access into the city. This eventually opened in 1911.

A total of 40 – 50 new members signed up to join the club & purchased debentures and a mortgage was taken out which gave a total working capital of c. £800. This allowed them to purchase Section 26 of the Township of Wadestown (today 46 Pitt Street) on 29<sup>th</sup> September 1909. Shortly after, tenders were called for the construction of the club rooms which were constructed to a design by Mr D Hay and subsequently opened by the Mayor, Dr Alfred Newman on 9<sup>th</sup> February 1910. The club originally featured a main hall, a billiard room, a cardroom (also used for boardgames) and dressing rooms for performances.

The club appeared to operate more as a social / community centre than as a classic 'gentlemen's club' and was used for amateur performances, candidate meetings before local and general elections, cooking demonstrations and concerts. However, interest in the club from the community began to decline in the 1920s and efforts by the committee to encourage new membership were unsuccessful. It is also likely that the economic effects of the Great Depression also had an impact on membership and as a result, the committee made the decision in 1930 to close the club down and liquidate its assets.

The Wellington City Council had been investigating the establishment of a branch library in Wadestown as early as 1927 following the acquisition of a parcel of land which might have been suitable. However, the process was put on until after the 1927 Local Body elections after which the Libraries Committee of the new Council agreed in principle to establish several suburban branch libraries across the city (including Wadestown).

On 30th July 1930, the Wadestown Club (in liquidation) offered to hand-over the site and building to the Wellington City Council (suggesting that a library could be a potential use) on the condition that the Council also take on the debt of £320 owed by the club. This debt consisted of a mortgage of £300 at 7% interest, a £15 outstanding bill to cover the cost of converting and wiring the property for 230v AC mains electricity and £5 in outstanding interest. With the rateable value of the property

# being £735, the Council readily agreed to the proposal and the property was transferred to the ownership of the WCC.

The rooms were briefly leased to the Wellington Education Board for use as a school hall and to a local church for use as a Sunday School but in 1932 the decision was made to convert the hall into the Wadestown Library at an estimated cost of £91, a decision which was widely supported by the local community. The building remained operating as the Wadestown Library until the new (present) library opened in 1988 after which it was converted to become the Wadestown Community Centre.
