2.1 Roading

Steve Wright, Team Leader of Resurfacing and Contracts at Wellington City Council, was present to advise on any roading matters. Steve advised the Board that funding from the Council for roading in the area would not have to be applied for every year; it would roll over.

There was a discussion on the school bus shelters in Ohariu. The Board was advised that Greater Wellington Regional Council has now taken responsibility for bus shelters. Steve is going to install some new school bus route signs in Ohariu, and find out the contact person for bus shelters at the regional council.

The Board also discussed car and horse float parking possibilities at Spicer Forest.

2.3 Greater Wellington Regional Council Resource Consent

Wellington Water was granted a global resource consent, although there was not adequate notification about it or the activity it is generating at South Karori Road and South Makara Road. The Chair has spoken to Cr Andy Foster and others, and has been assured that she will be notified of such consents granted in the future.

The Board also discussed to an email received by the Chair for a suspension bridge in the Makara Peak mountain bike park.
