C.H IZARD BEQUEST AND SOCIAL AND RECREATION FUND -MARCH 2017, SPORTSVILLE PARTNERSHIP FEASIBILITY FUND AND MULTI-YEAR CONTRACT FUNDING

Purpose

1. To provide recommendations for allocation of funding through the CH Izard Bequest, the Social and Recreation Fund, the Sportsville Partnership Feasibility Fund and for Multi-year contract funding (from 1 July 2017)

Summary

- 2. The Council provides grants to assist community groups and organisations to undertake projects that meet community needs. Grants are also a mechanism for achieving the Council's objectives and strategic priorities, especially those priorities that rely on community organisations carrying out specific activities.
- 3. A range of organisations are funded through multi-year contracts, these organisations include the network of community run community centres and others delivering to social, arts, environmental and community well-being outcomes.
- 4. The C.H. Izard Bequest has been managed by Council since 1925. The capital is managed by trustees; Macalister, Mazengarb Solicitors and an annual allocation made for distribution.

Background

- 5. Grants and funding are included in the Annual Plan to provide an appropriate mechanism for the Council to respond to community groups and organisations that are undertaking projects that:
 - Meet a need identified by the community.
 - Align with council's strategic goals and community outcomes.

- Rely to some extent on participation and engagement by community organisations
- 6. Organisations and projects are funded through both contracts and contestable grants pools. The contestable pools provide grants that are discretionary, short term and generally project based in nature. The Council also enters into multi-year contracts when it has an interest in ensuring particular activities occur that contribute to Council's strategies or policies.
- 7. The Strategy and Policy Committee agreed (in April 2005) to a re-configured grants framework in which organisations whose activities directly contribute to Council's strategic or policy goals would be funded through a detailed contractual arrangement a review of the funding and outcomes achieved at the end of the contract (generally three years).
- 8. These organisations and the specific needs they meet are critical to Wellington, contributing to Wellington's sense of place and are part of the city's infrastructure. Organisations that are funded through three year contracts are considered sustainable in the long term but need some financial support and some certainty of funding.
- 9. Organisations funded by the Council through multi-year contracts need to meet the relevant fund criteria (in the case of multi-year contract applications in this paper) the Social and Recreation Fund criteria (Attachment 1). In addition to meeting criteria:
 - The organisation is well-established and with some Council funding is sustainable in the long-term.
 - The organisation is generally regarded as a feature of Wellington's infrastructure or unique sense of place.
 - The Council does not wish to influence its day to day activities but has a strong interest in the outcomes of the organisation and can influence these through results based reporting.
 - A partner relationship is beneficial
 - Activity has alignment with Council's outcomes and policies.
- 10. To ensure funds are used appropriately, conditions may be suggested should funding be approved. This is usually in cases where applicants need to use funds for a specific aspect of their budget or where landowner approval or the approval of plans/designs. The original information provided through online application has been made available to Councillors.

CH Izard Bequest

11. Charles Hayward Izard served on the Wellington City Council and then as a MP, he gifted Izard Park in memory of his son C.B. Izard, the park is adjacent to Otari Wilton Bush and bears the family name. The trustees of the C.H. Izard Bequest have advised that up to \$20,000 is available fund for allocation to suitable projects recommended to them by the Grants Subcommittee.

Social and Recreation Fund

12. This is the second of two funding rounds in 2016/17. In August 2016 key fund priorities were identified, in assessing applications against the funding criteria Officers have prioritised projects which can show evidence based need and have positive social impact these priorities:

- Vulnerable groups, including; refugees, street communities and place based programmes, e.g. in Strathmore Park
- Community and neighbourhood resilience
- Wellington working towards being a UNICEF child and youth friendly city
- Community safety initiatives

Sportsville Partnership Feasibility Fund

- 13. The Sportsville Partnership Feasibility Fund was established in 2016/17 to provide support for projects in their developmental phase and acknowledges that projects may require the development of business cases, planning (e.g. developing constitutions and financial systems) and resource consent studies, and other information. Project should show evidence of community support, collaboration, and building partnerships with other organisations, and demonstrate that there is community need for the facility.
- 14. Projects supported through the feasibility funding will contribute to the development of 'Sportsville' approaches which allow for community and sporting groups to share facilities, e.g. changing rooms, fields, administration, social space, meeting rooms etc, which brings economies of scale to the cost of providing and maintaining these facilities.

Multi-year Contract funding

- 15. There are 64 organisations funded through multi-year contracts in 2017/18, these deliver on outcomes relating to Social and Recreation, Arts and Culture and the Environment. A list of 2016/17 contracts is included as Attachment 2).
- 16. Within all funding applications to Wellington City Council groups and organisations are asked to demonstrate how they do or will work in partnership with other organisations and the Council, how they evaluate their activities and their commitment to the Treaty of Waitangi.
- 17. To ensure funds are used appropriately, conditions may be suggested should funding be approved, typically where reports have not been received for previous grants.
- 18. Recommendations for funding (included in attachment 4) are for funding from 1 July 2017 and subject to approval of the 2017/18 Annual Plan.

Discussion: CH Izard Bequest

- 19. The CH Izard Bequest has specific criteria in addition to meeting Council's general Social and Recreation Fund criteria (attached as Attachment 1), though less emphasis on Council's strategic priorities is required.
- 20. Specific criteria relating to C.H. Izard Bequest:
 - Charitable and/or educational purposes and must fit the 'charitable mould', and may or may not have an educational purpose.
 - Charitable is interpreted as "needy" in the social welfare sense, not simply as a charitable trust.
- 21. We received 23 applications, seeking \$120,821, Officers are recommending five organisations be supported with a total of \$20,000. Recommendations, including amounts requested, contributed by organisations and Officers comments are listed in attachment 3.

Discussion: Social and Recreation Fund

- 22. We received 35 applications, seeking \$356,632, this includes three projects which have been transferred from the CH Izard Bequest and the Our Living City Fund, all of which meet criteria for this fund. Applications include 11 local residents or progressive associations who can request up to \$1,500 each financial year as a contribution to their operating expenses, specific criteria for these groups are listed in attachment 1.
- Officers are recommending 27 organisations be supported with grants totalling \$94,100. Recommendations, including amounts requested, contributed by organisations and Officers comments are listed in attachment 3.

Discussion: Sportsville Partnership Feasibility Fund

- 24. Officers are recommending the Grants Subcommittee support the Mornington Golf Club with a grant of \$15,000 is approved to undertake a Feasibility Study which will help the club better understand the need for an Accessible Sports Centre at the Mornington Golf Club. In addition, the Mornington Golf Club and Council also wish to identify/investigate how the club could be more sustainable in the long-term. Recommendations, including amounts requested, contributed by organisations and Officers comments are listed in attachment 3.
- 25. The feasibility study will:
 - Identify the need for an Accessibility Sports Centre, including current and projected demand
 - Identify other existing sport programmes and facilities for people with disabilities in Wellington
 - Review the existing accessibility programmes at the Mornington Golf Club including their sustainability
 - Review the Mornington Golf Club's financial position and identify how the golf club can be sustainable long-term
 - Review and comment on the building concept design
 - Identify other recreation opportunities that would assist the sustainability of the Mornington Golf Club
- 26. The following organisations/individuals will be consulted with, in addition to Wellington City Council: Mornington Golf Club, Special Olympics Wellington, Parafed Wellington, IHC, The Blind Foundation, Fuse IHC Youth Group, Mash Trust Mental Health & Addiction and other relevant/key organisations such as other clubs based at Wakefield Park or in the surrounding area.

Discussion: Multi-Year Contract Funding

- 27. Through the Social and Recreation Fund, eight organisations are seeking contract funding. A list of current contract funding (2017/18) is included as attachment 2, note this also includes contract funding for organisations delivering to Arts and Culture and Environmental projects. An extraordinary Grants subcommittee in June will meet to discuss a further two multi-year funding applications.
- 28. Applicants include local organisations delivering youth development programmes in the city, and two organisations operating community facilities, recommendations for these organisations are for two year funding in line with other community centre multi-year funding contracts.
- 29. Officers work with organisations to agree on a detailed set of performance outcomes which are reviewed annually based on accountability reporting provided by the organisations. Funding is released on receipt of satisfactory reporting and when agreements are in place.

Priority will be given to projects that:

- support projects that enhance community safety and/or personal safety.

Physically active communities encouraging health and wellbeing

Priority will be given to projects that:

- target communities of interest, including youth and seniors.
- support the strategic planning of sports codes.

Youth

Priority will be given to projects that:

- involve young people in the development and delivery of the project
- help young people gain a better understanding of community, an increased sense of belonging as active citizens and positive contributors to society
- promote volunteer opportunities for young people.

Community preparedness

Priority will be given to projects that:

- strengthen local neighbourhood connectedness in an ongoing manner
- increase community resilience and emergency preparedness locally.

Additional criteria for residents and progressive association applicants

The organisation must:

- be registered with Wellington City Council Community Services as a residents/progressive association, contact our Senior Advisor Funding and Relationships on 803 8525
- have a committee
- meet at least twice a year and keep minutes of these meetings
- have an active membership of 10 or more, excluding the committee
- keep accurate and detailed accounts
- agree to make their accounts and minutes available to Wellington City Council on request.
- You will need to be a legal entity (as per the Social and Recreation Fund criteria)
 When submitting an application residents and progressive associations should
- give a summary of their current membership and how often they hold meetings
- provide a copy of minutes from recent meetings.

CH Izard Bequest

This grant helps charitable causes in great need.

Value

Approximately \$30,000 is available to allocate per year.

About the grant

The Council administers the CH Izard Bequest on the trustee's behalf.

To be eligible, projects must:

- be for educational purposes or to support needy, disadvantaged groups in the community
- be an application from a group or organisation (individuals are not eligible)
- be within the Wellington city rate-paying area

Criteria

- 1. Your project makes a positive contribution to achieving the Council's Strategic Outcomes and points of difference as listed in our Annual Plan.
- 2. The project is Wellington based and primarily benefits the people of Wellington city.
- 3. The applicant is a legally constituted community group or organisation, not an individual or individuals. (Groups may apply under an appropriate umbrella organisation.)
- 4. The applicant group provides evidence of (or, if a new group, systems for):
- sound financial management
- good employment practice (where applicable)
- o clear and detailed planning
- o clear performance measures
- o demonstrated ability to report back on past funding as appropriate.
- 5. Projects will not be funded for the same purpose more than once in any financial year.
- 6. Failure to report adequately on past Council funding can result in a group being considered ineligible for future funding.
- 7. The project should be physically and financially accessible either by a wide range of people or by the intended users.

- The project should show evidence of community support, collaboration and building partnerships with other organisations (such as letters of support from other organisations / leaders).
- The applicant must demonstrate that the project expands the capacity, range or level of similar types of services in the community and that it has involved users in identifying the need for the project.
- 10. The principal intent of the project is not for private or commercial financial gain, though such gains may occur as a side effect of the project.
- 11. The application must demonstrate an awareness of the Treaty of Waitangi, in particular when involving mana whenua and taura here.
- 12. The project is for a charitable and / or educational purpose.

Sportsville Partnership Feasibility Fund

This fund aims to provide funding towards the development of sports facilities and partnerships at major sporting and recreation hubs in Wellington City.

About this funding

- The Sportsville Feasibility Fund of \$40,000 per year has been established to support feasibility studies for sportsville projects.
- An additional fund the 'Sportsville Partnership Fund' of \$500,000 per year is proposed from 2018/19 to assist with the design and construction stage of projects. Applications for this partnership fund will open in mid-2018.

'Sportsville' brings economies of scale by providing shared facilities and services for sports clubs and codes, eg changing rooms, fields, administration, IT services, social areas.

Successful Sportsville projects enable clubs to focus on developing and improving services for existing and potential members. Background information is available within the hubs and sportsville partnerships section.

The feasibility fund aims to support projects in their developmental phase and acknowledges that projects may require the development of business cases, planning (e.g. developing constitutions and financial systems) and resource consent studies, and other information.

Priority sites

The Council has identified some hubs as priorities and is focusing its resources on these priority sites.

Council outcomes

Projects will need to demonstrate that they make a positive contribution to achieving the Council's strategic outcomes.

Towards 2040: Smart Capital strategy

- People Centred City: Contributes to healthy, vibrant, affordable and resilient communities, with a strong sense of identity and 'place' expressed through urban form, openness and accessibility.
- Connected City: Supports a city with easy physical and virtual access to regional, national and global networks.
- Eco-City: Allows the city to proactively respond to environmental challenges and seize opportunities to grow the green economy.
- Dynamic Central City: Supports a central city of creativity, exploration and innovation, helping Wellington to offer the lifestyle, entertainment and amenity of a much bigger city.

Our Capital Spaces – an Open Space and Recreation Framework for Wellington

Projects supported will contribute to the Councils' strategic goals, as outlined in Our Capital Spaces – An Open Spaces and Recreation Framework for Wellington: 2013–2023. One of these goals is to have shared facilities in major sport and recreation hubs located in Wellington City, e.g. Kilbirnie Park, Hataitai Park, Wakefield Park.

Sportsville Partnership Feasibility Fund criteria

Projects must be Wellington-based and mainly benefit the people of Wellington City.

The project should show evidence of community support, collaboration, and building partnerships with other organisations, and:

- demonstrate that there is community need for the facility. The feasibility study must include a comprehensive needs assessment
- show alignment with Council service levels and provision (for sport and recreation facilities), and have support from regional and national sporting bodies e.g. Sport Wellington and Sport New Zealand
- demonstrate that the facility is identified as a major sport and recreation hub and is located in Wellington city.

Applicants must demonstrate that there are no existing facilities, or existing facilities are aging, unsustainable (no longer fit for purpose) and in need of replacement, and:

 that the new facility or partnership will improve and rationalise the sporting and recreation facilities in the area and region and generally support outdoor multipurpose sports use. It will improve community involvement and promote health and physical activity within the local and wider community.

Applicants will show evidence that the project can be partly self-funded. There needs to be over 50% funding that is independent from Council's contribution for the design and construction stage (this is a guideline only and not an indication of the amount of funding the Council will provide).

Applicants must be a legally constituted not-for-profit community group, trust or organisation, ie Incorporated Society or Charitable Trust, and financially sound.

- Applicants will show evidence of good financial management and organisational practices, eg clear and detailed planning and reporting processes, or (for newly established groups/trust/organisations) evidence to show that processes are in place to support ongoing financial management. This information should be part of a Business Plan.
- Applicants cannot be individuals, commercial, or 'for profit' organisations.
 These funds will not support retrospective funding applications, debt funding, or operation and/or maintenance costs.

Making an application

The detailed proposal will include the following:

- A description of the scope of the work, including:
- a description of any existing facilities
- site plans
- stages of the project.
- An indicative budget for design and construction including an outline of how the balance of funding for design and construction will be sourced (from other income, grants, donations, bequests etc).
- At least one recent quote or estimate (within 3 months of the closing date) from a professional, that relates directly to the feasibility work applied for.
- Detailed planning and reporting processes, or (for newly established groups/trust/organisations) evidence to show that processes are in place to support ongoing financial management.

Please note that applications for this fund are made directly to Council's Parks, Sports and Recreation team and not via the Council online funding portal.

How applications are assessed and decisions made

- Applications will need to meet criteria for the fund.
- Though there is no current design criteria, Council are engaging with Sport New Zealand for an 'off the shelf' design for buildings for 'sportsville' type projects, these types of design would be encouraged.
- Funding decisions will be made by Council's Community, Sport and Recreation Committee.
- A signed Memorandum of Understanding with Council and the entity making the application will form part of the funding agreement. This will set out intentions of each party and shared objectives and outcomes.
- Council may impose conditions when offering grants which might include staged release of funding or specify the involvement of a Council Officer in meetings and negotiations with contractors.
- Unsuccessful proposals can be re-submitted for consideration at a later date.

Grant conditions

Council may impose conditions when offering grants, as set out below:

- 1. Grants will be subject to availability of funds in any particular year
- 2. Only one grant will be considered for each project
- 3. Approval of the consultant
- 4. Council officers must approve the scope/brief for the feasibility study before work commences
- 5. Council officers must approve the draft feasibility study before the final report is completed

- Grants and funding are included in the Annual Plan to provide an appropriate mechanism for the Council to respond to community groups and organisations that are undertaking projects that:
 - Meet a need identified by the community.

- 3. All funding applications, made online have been made available to all Councillors.
- 4. Organisations and projects are funded through both contracts and contestable grants pools. The contestable pools provide grants that are discretionary, short term and generally project based in nature. The Council also enters into multi-year contracts when it has an interest in ensuring particular activities occur that contribute to Council's strategies or policies.
- 5. This fund serves to support organisations and deliver on the City's Arts and Culture Strategy and Events Policy. Council's Long Term and Annual plans outline a number of activities that support the Arts and Culture Strategy, notably positioning Wellington as the place for all people to experiment with, learn about, and experience New Zealand's arts and culture, especially contemporary work.
- 6. Current Arts and Culture Fund priorities are:

Background

- 3. Grants and funding are included in the Annual Plan to provide an appropriate mechanism for the Council to respond to community groups that are undertaking projects that:
 - Meet a need identified by the community.
 - Align with council's strategic goals and community outcomes.
 - Rely to some extent on participation and engagement by community organisations
- 4. Organisations and projects are funded through both contracts and contestable grants pools. The contestable pools provide grants that are discretionary, short term and generally project based in nature. The Council also enters into multi- year contracts when it has an interest in ensuring particular activities occur that contribute to Council's strategies or policies.
- 5. Criteria for the Our Living City Fund are included as Attachment 1.

- 6. The assessment process funding may include consultation with; the applicant, persons or organisations referred to in the application and Council officers, these would be across a range of activity areas, in the case of these applications across Parks, Sports and Recreation (Biodiversity and Environmental Partnerships) and Community Services (Urban Agriculture).
- 7. To ensure funds are used appropriately, conditions may be suggested should funding be approved. This is usually in cases where applicants need to use funds for a specific aspect of their budget or where landowner approval or the approval of plans/designs. The original information provided through online application has been made available to Councillors.

Discussion

- 8. The Our Living City Fund supports community organisations for projects that meet the criteria for the fund. Funding is allocated to The Sustainability Trust through a multi-year contract which serves to support the work this organisation do from their Eco Centre on Forresters Lane and with community and environmental groups in the wider city and CBD with a focus on Urban Agriculture (\$30,300). In the 2016/17 Annual Plan, Council also made a commitment to support the Warm Up Wellington programme in 2016/17 (with \$20,000) from this budget.
- 9. This is second of two funding rounds for 2016-17 which had a closing date of 31 March 2017. The next funding round will close in July 2017. 15 organisations have requested \$34,665 in this funding round.
- 10. Officers are recommending the Grants Subcommittee support seven projects with grants totalling \$14,000.
