The substantive motion was put and declared CARRIED.

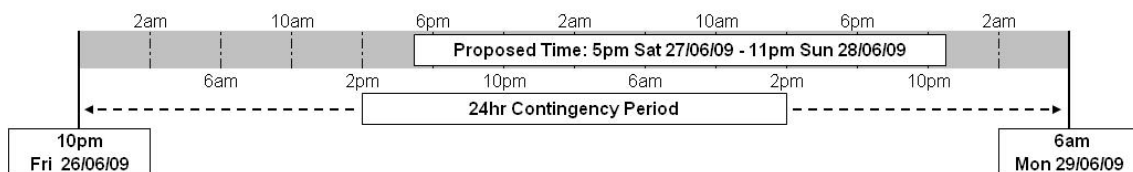
RESOLVED:

- 2. Agree to close the following roads for the event as shown, subject to the conditions listed in the Proposed Temporary Road Closure Impact Report:*

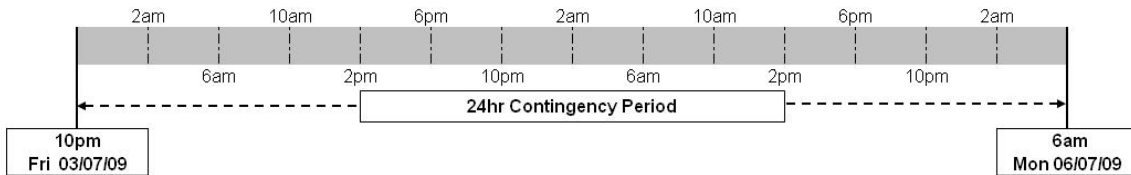
International Television Commercial Filming

- **Ghuznee Street** - (from Cuba Street to Marion Street - access to Leeds Street to be maintained), between 5pm Saturday 27 June and 11pm Sunday 28 June.
- **Abel Smith Street** - (from Willis Street to The Terrace), between 5pm Saturday 27 June and 11pm Sunday 28 June.
- **The Terrace** - (from Abel Smith Street to approximately number 355, just south of the Mercure Hotel), between 5pm Saturday 27 June and 11pm Sunday 28 June.
- As a **contingency plan**, if conditions are not deemed to be suitable for these times, it is proposed to close parts of Ghuznee Street, Abel Smith Street and The Terrace (as detailed above) for a 24 hour period sometime between 10pm Friday 26 June and 6am Monday 29 June.



- As a **further contingency plan**, if conditions are not deemed to be suitable the weekend beforehand, it is proposed to close parts

of Ghuznee Street, Abel Smith Street and The Terrace (as detailed above) for a 24 hour period sometime between 10pm Friday 3 July and 6am Monday 6 July.



- Bute Street** - (all of Bute Street from Vivian Street to the end of the street), between 7pm Monday 29 June and 7am Tuesday 30 June. As a contingency plan, if conditions are not deemed to be suitable on this date, it is then proposed to close the above road for a 12 hour period on the evening of Tuesday 30 June, Wednesday 1 July, or Thursday 2 July during the same times.
3. *Note that it is possible that not all the roads requested above will be required for the film shoot and may not actually be closed. The final road closures will be dependant on the director of the commercial - but will be within the parameters requested above. Where a contingency plan is implemented, further consultation and Traffic Management Plan development may be required to accommodate specific needs or impacts.*
