Land Transport Amendment Bill (No 4)

Public submissions are now being invited on this bill. Copies can be purchased at Bennetts
Government Bookshops.

This bill has two purposes. First, it clarifies the law regarding drug-impaired drivers.
Prosecuting a person driving under the influence of drugs has been difficult under the
existing offence. The new offence proposed in the bill is committed when a driver is
impaired and there is evidence of illegal drugs in the drivers blood. Impairment is a lower
threshold than the current offence "incapable of proper control" and is determined by a
more robust, published test.

Second, the bill establishes a regime that protects personal information held on the register
of motor vehicles but permits this information being used for purposes consistent with the
purposes of the register and such other purposes as the Minister of Transport may from
time to time decide.
