**Proposal:** No Stopping At All Times

Information: Residents on Quetta Street have raised issues with parking on their

> street on different occasions. The resident from #4 has raised issues over the parking being allowed next to and opposite their garage and has

requested the removal of parking. The concerns are as follows:

Quetta Street is only 6.0m wide. Cars parked in the space opposite # 4 is creating difficulty entering and exiting the garage owned by #4.

Parking adjacent to # 4 results in cars being parked partially on the narrow footpath and this often forces pedestrians to walk on the road. The Bombay Street stairs off Quetta Street (near # 6) is the preferred walking route for children and parents from Cockayne Road and Ellora Street as well as Quetta Street residents.

To address the above issues, it is proposed to install 4 metres of broken yellow lines opposite the garage of # 4 and 5 metres on the frontage of # 4 to maintain pedestrian footpath access.

Net parking loss: 2 parking spaces.
