## 110 JERVOIS QUAY - SR510418 - APPLICATION FOR RESOURCE CONSENT

Further to recent correspondence, please find enclosed updated documentation in respect of the above application for resource consent. The documentation reflects changes to the subject proposal following discussions with yourself, Wellington Water, tenant Victoria University of Wellington and further design work.

## Summary of design changes

Enclosed is a detailed outline of all the changes, prepared by Athfield Architects. In summary:

- Reduced scale and height of west wing.
- Adjusted floor to floor heights (reduced upper floors; adjusted heights on lower floors to accommodate VUW School of Music requirements).
- Revised lantern including additional part floor L8 adjacent to plant room.
- Façade design development and refinement.
- Ground floor:
  - o Changes to lobby location and number of lifts and related adjustments.
  - o Repositioning of end of trip facilities.
  - Reduced extent of retail premises at west end.
  - Minor landscaping revisions, including adjusted position of relocated Pōhutukawa following feedback from WCC.

Further to your email of 3 August 2022, we understand that these amendments would remain in scope of the original application submitted.
